

Limited Submissions Internal Application Instructions

This opportunity is relevant to those born in or after 1981.

Your application for the internal competition should include both your CV and your research summary as described in these two pages.

Your Curriculum Vitae (no maximum number of pages)

1. Name, current institution(s), and position title.
2. Education and training, including postdoctoral training and/or residency. Please list names of previous advisors.
3. Employment history.
4. Honors and awards including granting organizations and years in which they were received.
5. Select peer-reviewed publications – List only published work or manuscripts in press authored during independent career; do not include manuscripts that are submitted or in preparation or those published during graduate or postdoctoral studies. Conference abstracts and proceedings should only be included if they are the primary way of disseminating new results in your field, such as in computer science and mathematics.
6. Select patents and patent applications, patents & patent applications, including patent title, 1-2 sentence synopsis, and year submitted/approved.
7. Research grants – List funding for the main ongoing and completed projects on which you are a PI or a co-PI. Include name of funding mechanism, funder, and amount. For grants on which you are a co-PI, include total amount of grant overall as well as amount awarded to you.
8. Scientific Leadership, including any significant roles in the greater academic community. This includes major editorial responsibilities, public outreach activities, conference organization, institutional administrative responsibilities (e.g. Department Chair, departmental committee), contribution to diversity, equity, and inclusion initiatives, and service on external committees.
9. Invited talks and lectures, listing notable invited talks from the nominee's independent career, including keynote addresses and named lectures, with year given and inviting organization/institution.
10. Professional Service and Diversity, Equity, and Inclusion Statement, describing their outreach activities and/or professional service, with particular focus on activities and service related to increasing diversity, equity, and inclusion (DEI) in the scientific community.

Your Research Summary (1,000 words maximum)

1. Name which disciplinary category of Life Sciences, Physical Sciences & Engineering, and Chemistry to which you are applying. Please choose from the categories listed at this link:

2. Written in the first person;
3. Describe up to five of your most significant scientific contributions and research accomplishments from their independent career;
4. Be written to be accessible to another scientist working in their overarching disciplinary category (e.g., Life Sciences) but not necessarily in their specific field of study (e.g., Neuroscience);
5. Include key results, their impact on your field of study, and your specific role in the described work (especially where you were involved in large collaborations);
6. One figure illustrating the most significant results is allowed. Citations and figure caption do not count toward the word limit.
